Terms and Conditions for purchase of an Engraved Leaf

Please read these terms and conditions carefully before making your purchase.

For the purposes of these Terms and Conditions:

The "RSPB", "we", "our" or "us" shall mean THE ROYAL SOCIETY FOR THE PROTECTION OF BIRDS, a registered charity in England and Wales, number 207076 and in Scotland, number SC037654, whose registered office is at The Lodge, Sandy, Bedfordshire, SG19 2DL. For the purposes of these Terms and Conditions, the "RSPB" shall also refer to RSPB SALES LIMITED, a company registered in England and Wales under number 2693778, which is the wholly owned trading subsidiary of the RSPB whose registered address is The Lodge, Potton Road, Sandy, Bedfordshire SG19 2DL.

"You" or "yours" shall mean the person contracting with the RSPB for the purpose of purchasing (receiving in return for a donation) an engraved copper, brass or stainless steel leaf of a specified size (small, medium or large) to be engraved and displayed on the Sherwood Forest Dedication Wall ("Leaf").

Payment of your donation ("payment") is required in full in at the time you commission a Leaf. Following receipt of your payment, the RSPB will confirm your purchase by sending an email (the "Receipt") to the email address you provide at the time of purchase. The contract between you and the RSPB ("Contract") for the Leaf will only be formed when we send you the Receipt. These terms and conditions will govern the Contract.

You must check your Receipt carefully to ensure that it reflects your wishes with regard to your Leaf, including the type of metal chosen, the size of the Leaf (small, medium or large), the words to be engraved on the Leaf and the duration of display (3 or 5 years).

Any changes or mistakes in the Receipt must be brought to our attention within 24 hours of your receipt of the Receipt.

If you wish to cancel your order or change an element of your Leaf, you have 24 hours (calculated from when you receive your Receipt) to do so. If you choose to cancel within this time period, you will be entitled to a full refund of your donation. If you make a change to an element of your Leaf, you will be sent a replacement Receipt and these Terms and Conditions will continue to apply.

Because your Leaf will be personalised (engraved to your specific and individual requirements) we regret that RSPB is unable to provide any refund to you or make any changes to your Leaf after the expiry of 24 hours from when you receive your Receipt.

RSPB agrees to arrange for your Leaf to be engraved with words of your choice. The wording you choose for your personalisation must conform with our requirements in terms of font, size and number of characters, and must comply with all relevant laws and RSPB regulations. You must not choose any wording which may bring RSPB into disrepute. To this extent, RSPB shall have sole discretion to refuse to enter into a Contract with you, and may do so for any lawful and reasonable reason.

In the event that RSPB agrees that your Leaf does not correspond to your Receipt, RSPB shall, at its own cost and at its discretion, either amend the existing Leaf or arrange for a replacement Leaf to be engraved. You agree to allow a reasonable time for RSPB to re-engage your Leaf and/or to engrave and display a replacement Leaf.

RSPB shall endeavour to ensure that your Leaf is displayed on Sherwood's Tree of Life within 6 weeks of your purchase.

You acknowledge that, whilst RSPB will take all reasonable steps to maintain Sherwood's Tree of Life and your Leaf, during the period of display some weathering may naturally take place. You acknowledge that, when your chosen period of display is due to come to an end, RSPB may contact you (or you may contact RSPB) to ask if you wish to make a further donation in return for your Leaf continuing to be displayed, or if you would like your Leaf to be sent to you. In the event that you decide to extend the display period of your Leaf, the terms of the Contract will continue to apply for the extended period. In the event that you would like your Leaf to be sent to you, you agree to pay to RSPB a reasonable sum reflecting packaging and recorded postage. As an alternative to these options, or in the event that RSPB is unable to contact you after making reasonable attempts, or does not contact you and you do not contact RSPB with regard to your Leaf, RSPB will recycle your Leaf for use by others or in another setting or for a different purpose, provided always that RSPB shall firstly arrange for the removal of any personalised engraving on your Leaf.

Nothing in these terms and conditions or in the Contract excludes or limits in any way our liability for death or personal injury caused by our negligence or that of our employees or agents, or for fraud or fraudulent misrepresentation, or for any other matter for which it would be illegal or unlawful for us to exclude or limit (or attempt to exclude or limit) our liability.

RSPB will not be liable for any loss or for any failure to perform or delay in performance of any of our obligations under the Contract caused by an event outside our reasonable control, or caused by your own action or omission (which shall include any mistake in your Receipt). RSPB will not be liable for any indirect or consequential loss suffered by you, and our total liability to you in respect of all other losses arising under or in connection with the Contract, whether in contract, tort (including negligence), breach of statutory duty, or otherwise, shall in no circumstances exceed the amount of your donation made in return for a Leaf.

RSPB acknowledges that the personal information provided by you in connection with the purchase of a Leaf amounts to personal data. Such personal information will be processed in accordance with the requirements of applicable data protection law and our privacy policy. For further information on how we will use the information you have provided to us, please read our privacy policy on the RSPB website.

You agree that we may transfer our rights and obligations in this Contract, and that we may subcontract our rights and obligations under the Contract, provided that this does not affect your rights under these terms and conditions.

These terms and conditions and any document expressly referred to in them are intended to represent the entire agreement between us in relation to the Contract. If you would like to request any variations, please do so in writing and we will respond in writing.

A person who is not a party to the Contract shall not have any rights under or in connection with it by virtue of the Contracts (Rights of Third Parties) Act 1999.

These terms and conditions shall be governed by English law and shall be subject to the exclusive jurisdiction of the English courts.
